## I. ORGANIZATION STRUCTURE

### A. TOURNAMENT: National Team Trials

The 2024 United States Wushu-Kungfu Federation (USAWKF) National Junior Taolu and Sanda Team Trials, National Taijiquan Team Trials, National Sanda Championships and National Kungfu Team Trials will be held from May 25 to May 27, 2024, at the Santa Clara Convention Center in Santa Clara, CA. This team trials event will select the Junior Wushu Taolu Team to represent the U.S. in the 9th Junior World Wushu Championships to be held in Brunei Darussalam from September 22 to September 30, 2024, and the 4th World Taijiquan Championships to be held in Singapore from August 21 to 28, 2024. All team trials events in this tournament will select multiple teams to represent the U.S. in the 14th Pan American Wushu Championships and Pan American Wushu Kungfu Tournament, also to be held in Santa Clara, CA, from August 31 to September 2, 2024."

### B. HOST: USAWKF

The United States Wushu-KungFu Federation (USAWKF) is the official and exclusive representative of the International Wushu Federation (IWUF), which encompasses 146 member countries. It is also recognized by the International Olympic Committee as an international single-discipline sports organization. The USAWKF is responsible for promoting, organizing, and managing wushu-related activities in the United States, including national team selection, and representing the United States in international official events organized by organizations such as the International Wushu Federation, among others.

## IV. USAWKF NATIONAL JUNIOR WUSHU TAOLU TEAM TRIALS REGULATIONS

### A. ELIGIBILITY

**USAWKF National Junior Taolu Team Trials** – Eligible competitors must be U.S. citizens in possession of a valid US passport and must be current USAWKF members in good standing.

Group A: competitors who were born between January 1, 2006 – December 31, 2009

Group B: competitors who were born between January 1, 2010 – December 31, 2012

Group C: competitors who were born January 1, 2013, or later.

### B. TEAM COMPOSITION

- A Team – 12 athletes: 6 Boys and 6 Girls ranked 1<sup>st</sup> and 2<sup>nd</sup> in Groups A, B & C
- B Team – 12 athletes: 6 Boys and 6 Girls ranked 3<sup>rd</sup> and 4<sup>th</sup> in Groups A, B & C
- C Team – 12 athletes: 6 Boys and 6 Girls ranked 5<sup>th</sup> and 6<sup>th</sup> in Groups A, B & C

### C. COMPETITION EVENTS

- **Group A:** 3rd Set of International Competition Routine: Changquan, Daoshu, Jianshu, Qiangshu, Gunshu, Taijiquan, Taijijian, Nanquan, Nandao and, Nangun
- **Group B:** Changquan, Daoshu, Jianshu, Qiangshu, Gunshu (1st Set of International Competition Taolu), Nanquan, Nandao, Nangun (International Compulsory Routine) 42 Forms Taijiquan, and 42 Forms Taijijian
- **Group C:** Changquan (No.3 Elementary Routine), Daoshu, Jianshu, Qiangshu, and Gunshu (Elementary Routine)

### D. COMPETITION METHODS

Competition includes individual competition only.

Unless otherwise stated within these regulations, the competition will be conducted in accordance with the IWUF Wushu Taolu Competition Rules & Judging Methods (Excerpt) 2019 and utilize the Non- Degree of Difficulty Scoring Method (comprising of A Group – Quality of Movements Scoring & B Group – Overall Performance Scoring only).





**Time limit:**

- a. Group A Compulsory Form Routines:
  - For Changquan, Daoshu, Gunshu, Jianshu, Qiangshu, Nanquan, Nangun & Nandao, each routine's duration shall be no less than one minute and ten seconds (1min 10s).
  - For Taijiquan and Taijijian, each routine's duration shall be between three (3) to four (4) minutes.
- b. Group B Taijiquan & Taijijian Routines:
  - 42 Forms Taijiquan: 5-6 minutes; 42 Forms Taijijian Routine: 3-4 minutes.
  - There is no time requirement for other events.

The power of interpretation of the Rules rests solely with the USAWKF.

## **E. TEAM SELECTION METHODS**

For Age Groups A, B, and C, selection is based on the combined scores of their highest-scoring events in the barehand and weapon categories.

The 1st- and 2nd-ranked boys and girls will make up the National Junior A Team.

The 3rd- and 4th-ranked boys and girls will make up the National Junior B Team.

The 5th- and 6th-ranked boys and girls will make up the National Junior C Team.

## **F. TIE SCORES**

Tie scores affecting the selection of athletes for the A, B and C Teams will be broken using the following methods:

The athlete with higher rankings in his/her events will be selected.

The athlete with higher barehand score in his/her events will be selected.

- a. If a tie still results from i) above, the athlete with the highest individual event score will be selected.
- b. If a tie still results from ii) above, the athlete with the higher "overall performance" score (from B judges) in the bare hands event with highest score will be selected.
- c. If a tie still results from iii) above, the athletes will draw lots to determine the selection.

## **G. PLACING AND AWARDS**

The A Team will represent the United States in the World Junior Wushu Championships as well



as other international wushu tournaments. The A, B, and C Teams will represent the U.S. in the Pan American Wushu Championships held at the same place from August 31 to September 2, 2024, as well as in other international wushu championships. (Pending the IWUF and PAWC Regulations).

Athletes selected for teams will be awarded certificates accordingly, and their names will be published on the USAWKF official website.

Certificates of National Ranking shall be awarded to the top 10 boy athletes and the top 10 girl athletes of Group A, Group B and Group C using the combined scores of their two highest of Bare hands and highest scored weapon events.

## V. National Taijiquan Team Trials Regulations

### A. ELIGIBILITY

**USAWKF Taijiquan National Team Trials** – Eligible competitors must be U.S. citizens in possession of a valid US passport and must be current USAWKF members in good standing.

### B. TEAM COMPOSITION

- 16 athletes: 8 Men and 8 Women
- Half of the team is reserved for Championship Events with the other half reserved for Demonstration Events. Please see the Selection Method section for more details.

We are still awaiting the PAWF and IWUF Regulations. Any differences will be adjusted and updated only before the registration deadline.

**D. COMPETITION METHODS**



- A. The Taiji Team Trial optional event scoring will be based on Nandu event scoring methods. The 3rd Compulsory Taiji event will be scored as Nandu event equaling 10 points. All other standard forms scoring will be based on non- Nandu scoring methods.
- B. Routine Duration Standards:
- a) For Optional routine events and 3rd set Compulsory Taijiquan & Taijijian Routines: Routine time duration is between 3 minutes and 4 minutes in total.
  - b) For Compulsory Yang Style Taijiquan (40 Movements), Chen Style Taijiquan (56 Movements), Compulsory Wu Style Taijiquan (45 Movements), Compulsory Sun Style Taijiquan (73 Movements), 42 Movements Taijiquan: Routine time duration is between 5 and 6 minutes in total.
  - c) For Simplified 24 Movements Taijiquan: Routine time duration is between 4 and 5 minutes in total.
  - d) For Simplified 32 Movements Taijijian and 42 Movements Taijijian: Routine time duration is between 3 and 4 minutes in total.
  - e) For Traditional Taijiquan routines: Routine time duration is between 4 minutes to 5 minutes in total.
  - f) For Traditional Taijijian routines: Routine time duration is between 3 minutes to 4 minutes in total.
- C. Optional Taijiquan and Taijijian routines (with degree of difficulty movements) are required to be performed with accompanying music. 0.5 will be deducted for routines performed without musical accompaniment or those that utilize music with lyrics.

The power of interpretation of the Rules rests solely with the USAWKF

## **E. TEAM SELECTION METHOD**

16 athletes will be selected consisting of 8 women and 8 men.

Athletes can register for one or both competitive and demonstration divisions, and they can register for multiple divisions. However, within the same category, there must be one Bare-hands event and one weapon event. Additionally, they can only represent one of the two groups if selected.

The selection will be based on the total combined score of highest taiji bare hands form score and weapon score within their selected divisions.



When an athlete is selected for both the championship division and the demonstration division simultaneously, prioritized for the championship division.

To qualify towards their qualifying combined score, athletes must meet the minimum individual event final score of 8.5 or above.

The top 4 women and top 4 men for the Championship Division and the top 4 women and top 4 men for the Demonstration Division will be selected.

## **F. VACANCIES**

In the event there are not 4 qualifying men or women in either the Championship or Demonstration Divisions, the qualifying athletes of matching gender from the other division will be selected to fill the remaining vacancies. If vacancies on the team still remain after all competitors with 8.5 or above in their individual event final scores have been placed, competitors who scored above 8.2 will be included in the order of highest individual event final score to 8.2. If all athletes who scored above 8.2 have been placed on the team and vacancies remain, those spots will remain vacant.

## **G. TIE SCORES**

The athlete with higher rankings in his/her events will be selected.  
The athlete with higher barehand score in his/her events will be selected.

- a. If a tie still results from i) above, the athlete with the highest individual event score will be selected.
- b. If a tie still results from ii) above, the athlete with the higher “overall performance” score (from B judges) in the bare hands event with highest score will be selected.
- c. If a tie still results from iii) above, the athletes will draw lots to determine the selection.

## **H. PLACING AND AWARDS**

The A Team will represent the United States in the World Junior Wushu Championships, The A, B, and C Teams will represent the U.S. in the Pan American Wushu Championships held at the same place from August 31 to September 2, 2024, as well as in other international wushu championships. (Pending the IWUF and PAWC Regulations).



Athletes selected for teams will be awarded certificates accordingly. The names of team members will be published on the USAWKF official website.

Certificates of National Ranking shall be awarded to the top 10 boy athletes and the top 10 girl athletes of Group A, Group B and Group C using the combined scores of their two highest of Bare hands and highest scored weapon events.

## VI. APPEALS

- A. An athlete or coach who wishes to file an appeal must do so within fifteen (15) minutes of receiving his final score. Any appeals submitted after this time has elapsed will not be considered.
  - a. Only the competing athlete or a coach from that athlete's school as listed on their registration papers will be authorized to submit an appeal. No other party's appeal will be considered.
- B. The written appeal and the \$200 cash fee must be submitted to the Jury of Appeal directly to the Chief Juror at the Jury of Appeal desk adjacent to the competition floor.
  - a. No one other than the Chief Juror is authorized to receive an appeal. No one other than the athlete or coach may deliver the appeal to the Chief Juror and the fifteen-minute time limit is in effect until delivered to the Chief Juror.
  - b. The appeal must be written in English and clearly state which area of scoring is being appealed and specifically list what change the athlete wishes to have made to the final score.
- C. The Chief Juror must write the time on the appeal when it is received who will confirm with the Timekeeper that the appeal was received in time.
- D. After the Chief Juror has received both the written appeal and the \$200 then confirmed with the Timekeeper that it was received in time, the Jury of Appeal and either the coach or athlete will retire to the designated Jury of Appeal Room where the appeal process will begin. No appeals will be discussed on the competition floor.
  - a. The Jury of Appeal, the athlete or coach (only 1 of the 2) will go into the Jury of Appeal room upon which the door will be closed and no one else will be admitted to the room until a decision is reached.
- E. The athlete or coach will state their appeal to the Jury and then provide their video evidence.
  - a. The video evidence must be incontrovertible to override the final score. If the video evidence is unclear, the current results will remain unchanged.



- F. The technical judges will review the video evidence and determine the merits of the appeal.
  - a. The technical judges also have the option to request the official video from the competition floor if more data is required.
- G. The athlete and coach will then be asked to retire from the Jury of Appeal room while the Jury votes.
- H. The 2 technical judges will explain to the Chief Juror and the other jurors their findings and then the technical judges will each cast the first and second votes on whether to validate the appeal or not.
- I. The other 2 jurors will then be asked to vote, and they will constitute the 3rd & 4th vote.
- J. The Chief Juror will then cast the 5th and final vote. The results of the 5 votes will constitute the Jury of Appeal final decision.
- K. The athlete or coach will be called back into the Jury of Appeal Room and duly informed of the results.
- L. If the appeal is validated, the \$200 will be returned to the athlete and the Chief Juror will inform the Chief Referee and Scorekeeper of the validated appeal and the final results will be changed.

The USAWKF reserves all rights pertaining to interpretation of the rules, team selection, and final team layout in the best interest of the federation and to uphold the sanctity, mission, and goals of the national team.

## **VII. COSTUMES & EQUIPMENT**

During all events, competitors shall wear wushu competition costumes that are in compliance with the rules and are provided by the competitors themselves.

All Taolu Wushu Team Trials weaponry shall conform to the requirements stipulated in the rules and must be provided by the competitors themselves.

## **VIII. PARTICIPATE REQUIREMENTS AND METHODS**

### **A. Insurance and Waiver of Liability Statement Requirements**



- a. All participants are required to purchase their own medical insurance, personal injury insurance, liability insurance, travel insurance, disease insurance, and other related insurance.
- b. Participants, whether registering online or in person, must have their legal guardians or authorized representatives agree to and confirm the waiver for this competition through the competition's online registration system or provide a waiver with a valid signature to the organizing committee during on-site Check-in, to be eligible to register for this competition.

## **B. Athletes Entry**

An athlete can only represent one team throughout the entire competition. However, they can simultaneously register for multiple competitions.

## **C. Team Entry**

### **a. Entry Methods of Team leader and Coaches:**

Each team may apply for 1 team leader and up to 1-2 coaches. Team leader and Coaches can obtain the necessary credentials either through the registration system or by reaching out to the organizing committee. Team leader and coaches with valid credentials enjoy complimentary access to the competition venue, as well as the exercise of team leader or coach authority.

### **b. Entry Methods of Team Judge:**

Teams with more than 20 members can apply for one referee (with international or national level wushu referee qualifications). After approval by the organizing committee, the team's submitted judge may serve as a competition judge.

### **c. Entry Methods of Masters and Team Demonstration:**

Master and Team Demonstration will take place during the opening ceremony of the competition. In addition to the master performers specially invited by the organizing committee, each representative team can apply for either a group performance or an individual performance. There is no limit on the number of performers for the group performance, and the total performance time must not exceed 4 minutes. To apply, teams must submit the following information: team introduction, team logo and photos, performance title, performer introductions and photos, performance duration, and performance music.

### **d. Entry Methods of Opening Ceremony**





- a) **Participation:** Both team and individual participants are required to attend the competition's grand opening ceremony on time.
- b) **Team Uniform:** It is recommended that all teams wear uniform or competition attire for the entry.
- c) **Team Flag and Team Entry Banner:** For teams with more than 5 participants, the organizing committee will provide team entry banner and team flag. Teams with fewer than 5 athletes will enter the opening ceremony alongside individual participants, following the individual entry banner and flag. Each team can collect relevant items during Check-In.
- d) **Team Flag and Team Barriers:**
  - Each representative team must nominate one team banner guide and one flag bearer to participate in the opening ceremony. The order of the teams' formation will be as follows: the Team Banner guide will be in the front, followed by the flag bearer, team leader, coaches, athletes, and accompanying members.
  - Each team also needs to provide the organizing committee with the team's name and the contact information of the flag bearer before the registration deadline, to facilitate the acquisition of information regarding the opening ceremony entry route and the arrangement for each group.
  - This year, the team entry order will be based on the first letter of each team's name, entering in reverse alphabetical order from Z to A. The entry route diagram and rehearsal times for entry guides and flag bearers will be announced separately.
  - After the conclusion of the opening ceremony, the banner guides and flag bearers from each team will be responsible for leading their respective teams in an orderly exit from the venue, and schedule times for rehearsal.

#### D. Volunteer Registration

In addition to the volunteer teams invited by the organizing committee, we encourage each delegation to recommend volunteer personnel to the organizing committee. The organizing committee will accept a certain number of volunteer teams based on volunteer application resumes and actual work needs.

- a. **Scope of Volunteer Work:** Volunteers will assist with various tasks related to the competition, including registration reception, record keeping, venue guidance, venue setup, accommodation arrangements, transportation services, ticket security, medical



assistance, award presentation center, video and photography, news coverage, procurement of supplies, catering services, sound services, program hosting, and more.

- b. **Volunteer Time Requirement:** The minimum service time should not be less than 5 hours. The organizing committee will provide volunteers with T-shirts and relevant credentials, complimentary tickets and meals during the entire volunteer work period, based on actual volunteer service hours and responsibilities. After the event concludes, volunteers will receive a certificate of appreciation and the total number of volunteer hours completed.
- c. Please register volunteer information before the registration deadline, and confirmation from the organizing committee will be considered final.

## IX. REGISTRATION PROCEDURES AND FEES

### A. Team Trials registration

National Junior Team Trials, National Taijiquan Team Trials, National Sanda Championships, and Team Trials: Register through USAWKF official website [www.USAWKF.com](http://www.USAWKF.com), and LOC Website <https://gowushu.com/registration/>. The registration URL will be posted on both of website before March 31, 2024.

**Registration Requirements:** National Junior Wushu Taolu Team Trial and National Taijiquan Team Trials competitors are required to show their valid US Passport and submit a completed and signed waiver of liabilities form, which has been signed by the competitor's parent or legal guardian if under 18 years of age.

### B. National Kungfu Team Trials registration

The Kungfu Team Trials coincide with the Golden State Championships. National Kungfu Team Trials participants are required to present a valid US Passport or residence permit document and submit a completed and signed waiver of liability form, which must be signed by the competitor's parent or legal guardian if under 18 years of age.

### D. Fees for Competitor

The National Junior and Taijiquan Team Trials Registration Fee is \$160 per event.



**Ticket “wristbands”**

## XI. OTHER REQUIREMENTS

### A. Competition Drawing Lots:

The time set for the drawing lots for the competition is from **8:00 AM to 11:00 PM** Pacific Time on **May 5, 2024**. The competition uses an online draw method to determine the order of appearance for each group of athletes. All team coach and individuals must carefully review the competition information before the draw date, and once confirmed, team leaders, coaches, or athletes themselves can participate in the online draw through the online registration system. Athletes who miss the draw or do not participate in the draw will be randomly assigned by the organizing committee.

After the drawing of lots, no further modifications to athletes' competition information will be allowed. Athletes who cancel their participation for any reason will be considered as forfeiting the competition, and no refunds will be issued.

### B. Event Modification and Refund Policy

- a. Prior to the registration deadline, athletes can contact the organizing committee via email, phone, or WeChat to make free modifications to their competition information or to cancel their participation and receive a full refund.
- b. After the registration deadline and before the drawing of lots, athletes who wish to make modifications or cancel their participation will be subject to a \$50 processing fee.
- c. After the drawing of lots, no further modifications to athletes' competition information will be allowed. Athletes who cancel their participation for any reason will be considered as forfeiting the competition, and no refunds will be issued.
- d. Competition fees will not be refunded in the event of a competition cancellation or delay due to force majeure.

### C. Early Check-in Procedures

Schools and Groups can contact the organizing committee one to two weeks in advance to complete the Check-in process in advance. The organizing committee will send relevant documents such as athlete credentials by mail to each representative team. Teams and individuals can also proceed to the location of the organizing committee's office in advance to complete the registration process early.

### D. Check In:

Teams and individual athletes are required to pick up their IDs at the check-in desk located in



the Convention Center lobby. Check-in times are scheduled for 10:00 am to 12:00 pm and 1:00 pm to 3:00 pm on May 25, 2024.

It is required that participating groups, teams, or athletes prepare the following:

- A copy of the signed Waiver of Liabilities
- Self-selected music for the routine in the form of a .mp3 file, if applicable.

**E. Technical Meeting**

The Technical Meeting for coaches (and athletes without a coach present) will take place at the Santa Clara Convention Center Expedition Hall lobby on May 25, 2024, from 2:00 pm to 2:30 pm local time, during which all matters related to the competition will be announced.

## **XII. ADMINISTRATION OF TEAM TRIALS EVENTS**

The Team Trials Organizing Committee will administer all aspects of the competitions under the auspices of the USAWKF Board of Directors.

Every athlete selected for the USAWKF Junior Taolu and National Taijiquan Teams must agree to participate in the World Junior Wushu Championships or other international events for which they are selected. The USAWKF Board of Directors reserves the right to determine a final composition of the U.S. National Taolu Team, which, in its opinion, serves the best interests of USAWKF.
