2024 USAWKF National Level Wushu Judges Certification Courses and Coach Training Courses

General Information

The USAWKF will hold National level wushu judge's certification courses and Coach Training Courses in Santa Clara, California, USA, starting May 22, 2024. The courses will offer participants the technical training to be a USAWKF-certified judge in either taolu or sanda. All USAWKF members are eligible to participant to these courses.

Date and Place

The USAWKF National Level Wushu Judges Certification Courses will be held for three days, from Wednesday, May 22 through to Friday, May 24, 2024, at the Delta Hotels Santa Clara Silicon Valley, 2151 Laurelwood Road, Santa Clara, California 95054 USA.

Participation

1. Qualification qualify Requirements:

- a. Applicant must agree to and signed to the Liability and Copyright Waiver form.
- b. Applicant must be a USAWKF member in good standing.
- c. Achieved a third-place or better finish at a USAWKF recognized or sanctioned tournament or served as a judge or coach at a USAWKF recognized tournament or for a USAWKF national team / delegation.

2. The participants who meet the registration requirements, follow the course content and examination regulations, and pass the examination will be eligible to receive the USAWKF National Level Judge certificate and/or Coach Training Certificate accordingly.

3. Non-Certification Participants

These training courses also welcome parents and athletes to participate. There are no specific eligibility restrictions. Participants who attend all the courses as required will receive a participation certificate.

4. Judges and Coaches course participants from the USAWKF are required to stay until the end of Monday, May 27, to judge at the USAWKF national taolu and sanda events scheduled for May 25-27.

Registration

Registrations must be submitted through the USAWKF registration system. A URL will be

provided and communicated to all USAWKF members. All sections of the registration form must be completed in full. Registrations must be submitted no later than 23:59 Central Daylight-Saving Time on April 21, 2024.

Arrival and Check-In

1. All participants are required to check in with the organizing committee at the 2024 USAWKF Judges and Coaches Course Registration Desk at the Delta Hotels Santa Clara Silicon Valley, not later than 20:00pm local time (PST) on May 21, 2024.
2. All participants must pay all required fees in full in U.S. dollars at registration and check-in. Failure to do so will disqualify those participants from attending the courses.

Financial Conditions

The participation fees are as follows:

1. Taolu Judge Certification Course: USD \$800
2. Taolu Coach Training Certification Course: USD \$800
3. Apply both of Taolu Judge and Coach certification course: USA \$1200
4. Sanda Judge Certification Course: USD \$800
5. Teaching Materials for each Course: USD \$50

Airfare and related travel expenses, as well as accommodations, meals, transportation, and participation fees shall be borne by the participants. To make hotel reservations, contact the hotel directly and mention the USAWKF Certification Course.
