## I. ORGANIZATION STRUCTURE

---

### 1. Host Organization: WTSF

The World Taiji Science Federation is composed of universities, scientific research institutions, health and wellness associations, medical health experts, researchers, and professors from the United States, Europe, and China. The Federation's primary mission is to contribute to the field of "Taiji Science" through research and events. It collaborates with American organizations and groups to analyze scientific experimental data, aiming to develop Taiji standards, certification programs, and educational initiatives for Taiji, Qigong, and other wellness practices. Through scientific research, international exchanges, forums, and festivals, the Federation promotes Taiji science, culture, and wellness globally.

The USAWKF is responsible for promoting, organizing, and managing wushu-related activities in the United States, including national team selection, and representing the United States in international official events organized by organizations such as the International Wushu Federation, among others.

### III. PARTICIPANT ELIGIBILITY AND INVITATION

---

1. Golden State International Wushu Championships: There are no specific eligibility restrictions for participation, and we warmly welcome individuals, groups, and even spectators from all around the world to actively take part.
2. USAWKF National Kungfu Team Trials: Participants must be valid members of USAWKF and must either be U.S. citizens or permit resident.
3. USAWKF National Junior Wushu Team Trials, National Taijiquan Team Trials: Participants must be valid members of USAWKF and must U.S. citizens.
4. To join USAWKF please go to [www.usawkf.org](http://www.usawkf.org) to register.
5. The international participating teams or individuals should first submit the Preliminary Registration Form in the attachment. The organizing committee will issue an digital invitation letter for free based on the submitted content. If the original invitation letter is required, please contact the organizing committee to provide a valid mailing address and pay \$50 for the express delivery fee to handle international mailing.

### IV. COMPETITION GROUPING

---

1. **Grouping Principles:**
  - 1) Competition categories are established based on the difficulty level of the events, including Beginning, intermediate, and advanced forms. These categories dynamically differentiate forms such as Five-Step Fist, Elementary Long Fist, Compulsory Forms, and Optional Forms, and participants do not need to self-declare as “Beginning, Intermediate, or Advanced Levels.”
  - 2) Feature separate competitions for different styles and equipment categories.
  - 3) Grouping is designed based on the distribution of participants' ages and the number of participants in each event.
2. **Age Group**

### 3. All-Around Championship Group

The All-Around Championship will be separated into three different groups: traditional Kungfu all around championship, contemporary wushu all around championship and, Taijiquan and health qigong championship.

#### 1) Traditional and /or Contemporary Wushu All-Around Age Group:

- a. All-Around Group A: 7 years old and under, male or female
- b. All-Around Group B: 8-9 years old, male or female
- c. All-Around Group C: 10-11 years old, male or female
- d. All-Around Group D: 12-13 years old, male or female
- e. All-Around Group E: 14-15 years old, male or female
- f. All-Around Group F: 16-17 years old, male or female
- g. All-Around Group G: 18-21 years old, male or female
- h. All-Around Group H: 22-55 years old, male or female
- i. All-Around Group I: 56-89 years old, male or female

\* Any athlete registered in Contemporary Wushu, competing in at least one Contemporary hand form, one Contemporary short weapon event, and one Contemporary long weapon event, is eligible to apply for the Contemporary All-Around Championship:

\*Any athlete registered in Traditional Kungfu, competing in at least one Traditional hand form, one Traditional short weapon event or Soft Weapon, and one Traditional long weapon event, is eligible to apply for the Traditional All-Around Championship.

#### 2) Taiji and Health Qigong All-Around

- 1) All-Around Group J: 12 years old and under, male or female
- 2) All-Around Group K: 13-15 years old, male or female
- 3) All-Around Group L: 16-18 years old, male or female
- 4) All-Around Group M: 19-25 years old, male or female
- 5) All-Around Group N: 26-55 years old, male or female
- 6) All-Around Group O: 56-89 years old, male or female

\*Any athlete registered in Taiji and Health Qigong, competing in at least one hand form and one weapon event, is eligible to register in the All-Around Championship

5. **There are no all-around competitions, and no Team Trials** competitions for online competitions. The online competition events are the same as the in-person competitions, but the age groups for the competition are different. The specific age groups are as follows:

## V. PARTICIPATE REQUIREMENTS AND METHODS

---

### 1. Insurance and Waiver of Liability Statement Requirements

- 1) All participants are required to purchase their own medical insurance, personal injury insurance, liability insurance, travel insurance, disease insurance, and other related insurance.
- 2) Participants, whether registering online or in person, must have their legal guardians or authorized representatives agree to and confirm the waiver for this competition through the competition's online registration system or provide a waiver with a valid signature to the organizing committee during on-site Check-in, to be eligible to register for this competition.

### 2. Athletes Entry

An athlete can only represent one team throughout the entire competition. However, they can simultaneously register for multiple competitions.

### 3. Team Entry

#### a. Entry Methods of Team leader and Coaches:



Each team may apply for 1 team leader and up to 1-2 coaches. Team leader and Coaches can obtain the necessary credentials either through the registration system or by reaching out to the organizing committee. Team leader and coaches with valid credentials enjoy complimentary access to the competition venue, as well as the exercise of team leader or coach authority.

**b. Entry Methods of Team Judge:**

Teams with more than 20 members can apply for one referee with international or national level wushu referee qualifications. After approval by the organizing committee, the team referee may serve as judges for the competition.

**c. Entry Methods of Masters and Team Demonstration:**

Master and Team Demonstration will take place during the opening ceremony of the competition. In addition to the master performers specially invited by the organizing committee, each representative team can apply for either a group performance or an individual performance. There is no limit on the number of performers for the group performance, and the total performance time must not exceed 4 minutes. To apply, teams must submit the following information: team introduction, team logo and photos, performance title, performer introductions and photos, performance duration, and performance music.

**d. Entry Methods of Opening Ceremony**

- a) **Participation:** Both team and individual participants are required to attend the competition's grand opening ceremony on time.
- b) **Team Uniform:** It is recommended that all teams wear uniform or competition attire for the entry.
- c) **Team Flag and Team Entry Banner:** For teams with more than 5 participants, the organizing committee will provide team entry banner and team flag. Teams with fewer than 5 athletes will enter the opening ceremony alongside individual participants, following the individual entry banner and flag. Each team can collect relevant items during Check-In.
- d) **Team Flag and Team Barriers:**
  - Each representative team must nominate one team banner guide and one flag bearer to participate in the opening ceremony. The order of the teams' formation will be as follows: the Team Banner guide will be in the front, followed by the flag bearer, team leader, coaches, athletes, and accompanying members.
  - Each team also needs to provide the organizing committee with the team's name and the contact information of the flag bearer before the registration deadline, to facilitate the acquisition of information regarding the opening ceremony entry route and the arrangement for each group.



- This year, the team entry order will be based on the first letter of each team's name, entering in reverse alphabetical order from Z to A. The entry route diagram and rehearsal times for entry guides and flag bearers will be announced separately.
- After the conclusion of the opening ceremony, the banner guides and flag bearers from each team will be responsible for leading their respective teams in an orderly exit from the venue, and schedule times for rehearsal.

#### 4. Volunteer Registration

In addition to the volunteer teams invited by the organizing committee, we encourage each delegation to recommend volunteer personnel to the organizing committee. The organizing committee will accept a certain number of volunteer teams based on volunteer application resumes and actual work needs.

- 1) **Scope of Volunteer Work:** Volunteers will assist with various tasks related to the competition, including registration reception, record keeping, venue guidance, venue setup, accommodation arrangements, transportation services, ticket security, medical assistance, award presentation center, video and photography, news coverage, procurement of supplies, catering services, sound services, program hosting, and more.
- 2) **Volunteer Time Requirement:** The minimum service time should not be less than 5 hours. The organizing committee will provide volunteers with T-shirts and relevant credentials, complimentary tickets and meals during the entire volunteer work period, based on actual volunteer service hours and responsibilities after the event concludes, volunteers will receive a certificate of appreciation and the total number of volunteer hours completed.
- 3) Please register volunteer information before the registration deadline, and confirmation from the organizing committee will be considered final.

## VI. TIME REQUIREMENTS AND COMPETITION METHODS

---

### 1. Limitations on Time and Number of Participants

- 1) Athletes under the age of 18 are not subject to any time restrictions on their competition routines.
- 2) Athletes aged 18 and above must perform traditional kung fu routines for a minimum of 1 minute, while the compulsory routines and optional routines should adhere to the original requirements regarding the duration of the routines.
- 3) The Taiji and Health Qigong events, including individual and group forms, must not exceed 6 minutes in duration. Kung Fu group events must not exceed 4 minutes, and



duet events must be no less than 40 seconds.

- 4) Compulsory Wushu routines must be performed in the specified sequence without any additions, omissions, or alterations to the movements.
- 5) In Duilian and Group Events, there are no gender or age restrictions. Each group event must have a minimum of 6 participants, and for every participant fewer than 6, 0.5 point will be deducted.
- 6) When the number of participants in the same age group for each event is fewer than 3, they will be merged into similar competition events.
- 7) Music is not required, except some of the original forms are required with music.

## **2. USAWKF National Kungfu Team Trials Selection Methods (Member only)**

Athletes who score over 8 points in their in-person competition or achieve a top-three ranking are eligible for selection. Once selected, they are qualified to represent the USA Traditional Kungfu Team in world and international traditional Kungfu championships tournament, within two years.

## **3. Video Requirements for Online Competitions**

- 1) Athletes in the competition video must face the camera and perform a bow with fists when starting their routine.
- 2) Filming of the competition video can only use one camera, positioned at adult eye level for a frontal close-up shot. The camera can move left and right during the performance, and the focus may be adjusted as needed to ensure the athlete is not too small or out of frame. The entire demonstration should be recorded in one take without editing or switching shots. Multiple recordings are allowed, and the best one should be submitted.
- 3) The competition video must be a live recording and cannot have post-production edits or added audio or visual effects.
- 4) Filming Location
  - a. The choice of filming location does not affect the scoring and is entirely at the discretion of the participating athlete. Both indoor and outdoor locations are acceptable, if they are safe, suitable for a continuous demonstration of the routine, and filming.
  - b. The lighting and brightness of the video should be sufficient for judges to assess.
  - c. The video background must not feature commercial advertisements, religious or political propaganda. Martial arts school logos and national or regional flags are allowed, but virtual backgrounds are not permitted.
  - d. The competition video must strictly adhere to the video requirements and should be filmed within 2 months of the registration deadline.
  - e. When submitting the competition video, please include the athlete's name and



competition event code information in the video file name for easy organization and reference.

- 5) If the video requirements are not met during the competition, the judging team reserves the right not to score, and the registration fee will be non-refundable.

#### **4. Uniform and Weapon Requirements**

All athletes must wear performance uniforms and use competition equipment in accordance with the 2019 International Wushu Federation (IWUF) competition rules. However, there are no specific restrictions on the length and weight of the competition equipment.

#### **5. Competition Drawing Lots**

The competition uses an online draw method to determine the order of appearance for each group of athletes. All teams and individuals must carefully review personal and team competition information before the draw date, and once confirmed, team leaders, coaches, or athletes themselves can participate in the online draw through the online registration system. The draw time will be announced on the competition website, registration system, and through email notifications. Athletes who miss the draw or do not participate in the draw will be randomly assigned by the organizing committee.

## **VII. COMPETITION RULES**

---

### **1. Competition Format**

- 1) The competition consists of two formats: on-site competition and online competition. It also includes simultaneous events such as the USAWKF National Kungfu Team Trials, National Junior Wushu (Taolu) Team Trials, National Taijiquan Team Trials, as well as the National Judge Certification Course and an international master demonstration series of events and competitions.
- 2) The competitions consist of individual events, including individual, duilian, jiti (group), and all-around events. There are no team total score competitions. Additionally, online competitions do not include all-around event competitions.

### **2. Competition Rules**

Competition rules will be conducted in accordance with the 2019 International Wushu Competition Rules endorsed by the IWUF, all Traditional events shall adopt the 2019 Traditional Wushu Routine Competition Rules and our current regulations. Health Qigong Tournament shall adopt the 2012 Health Qigong Demonstration and Exchange Competition Scoring Guidelines authorized by the China Health Qigong Association and our current regulations. Contemporary wushu events will use non-nandu score method, and some of the rules that are not suitable for online competition scoring will not be deducted in this competition.

### **3. Arbitration Committee**

The selection of the Arbitration Committee members will be arranged by the Organizing



Committee of the Congress. The arbitration procedures and responsibilities for Wushu, Taiji, and Health Qigong will be carried out in accordance with the 2019 "International Wushu Federation Traditional Routine Competition Rules," "Arbitration Committee Regulations," and the provisions of these regulations. Online competitions will be conducted as applicable.

#### **4. Administration**

This competition will be held under the unified leadership of the organizing committee, and the final interpretation of the rules and regulations belongs to the organizing committee. In the event of disputes over the English interpretation of the rules and regulations, the Chinese version shall prevail.

#### **5. Suggestion and complaint**

To ensure the rigor and fairness of the competition, coaches and athletes not only have the right to file appeals during the competition according to the arbitration procedure, but we also encourage providing feedback and lodging complaints related to judges and judging panels by sending an email to [Forum@wtjsf.org](mailto:Forum@wtjsf.org). The Organizing Committee will consider this feedback and complaints when determining future referee selections and improvements.

## **VIII. JUDGE TEAM SELECTION AND JUDGING METHODS**

---

### **1. Judge Selection**

The Arbitration Committee Members, Chief Referees, Head judges, and scoring judge of each judge group are respectively held by professional referees at the international level, Pan American level, and national level, and priority will be given to the judges for the competition without students.

### **2. Score Methods**

Five judges give the score, remove the highest score and the lowest score, and the middle three scores are averaged; If there are only four judges, the highest score and the lowest score are removed, and the middle two scores are averaged; If there are only three Judges to score, the average of the three scores will be taken.

### **3. Time Conflict**

If there is a time conflict or if the competition times are too close, athletes can request in advance to the head judges of both venues for adjustments. The head judge may adjust the order of the athlete's competitions as necessary to ensure their participation. However, if, after all competitions within the same group as the athlete have concluded, the athlete is still unable to participate in their competition, that competition for the athlete will be considered forfeited.

### **4. Multiplayer simultaneous competition**

The judging panel may opt for a simultaneous participation format for multiple



contestants based on the style and characteristics of the event, while ensuring judging quality and venue safety.

#### **5. Head Judge's Scoring**

When there is a clear and obvious discrepancy in scoring, the Head Judge may award or deduct points before displaying the athlete's final score. The range for the scoring adjustment is between 0.01 and 0.05 points, and it does not require approval from the Chief Referee.

## **IX. RANKING AND AWARDS**

---

### **1. First-Time Participation Encouragement Award**

Athletes participating for the first time who do not receive any medals after completing all the events they have entered will be awarded an encouragement medal by the organizing committee.

### **2. In-Person Competition**

- 1) Athletes who rank in the top three in individual events will be awarded gold, silver, and bronze medals, along with corresponding digital certificates of ranking. Other athletes will receive digital certificates of ranking as awards.
- 2) For Duilian events, and group events, the awarding methods are the same as mentioned above, with medals distributed based on the actual number of participants in each Duilian or group.
- 3) In the all-around event, where athletes achieve the highest score and ranking from two or three individual competitions (please refer to the specific registration requirements for the All-Around Competition), the top three athletes will be awarded the title of All-Around Champion, along with a trophy, medal, and certificate.
- 4) The competition certificate is a digital certificate. Athletes can download it directly in the competition registration account. If the coach or school signs up on their behalf, please contact the coach and school to download the certificate.
- 5) Medals and trophies for in-person competitions can be collected directly at the onsite award receiving center.
- 6) The results of the all-around event will be announced only after the completion of all age groups. All-around trophies can be collected on-site.
- 7) Kung Fu team trial results will be announced on-site, but the Team certificates will be available for download from the competition registration account after they have been reviewed and confirmed by the USAWKF (about one week) .

### **3. Online Competition**

- 1) Gold, silver, and bronze awards are designated for each individual event, age group, and gender. Specifically, the top 20% will receive gold medals, the next



30% will receive silver medals, the following 30% will receive bronze medals, the remaining participants receive encouragement awards (participation certificates). The award proportions are determined based on the actual number of participants and are rounded accordingly.

- 2) The award certificates can be downloaded in the Competition registration account, and the medals for online competitions can be collected at the location of the organizing committee's office. Alternatively, you can arrange for postal service through the Competition sponsor, Kung Fu Direct, with postage and customs fees being the responsibility of the recipient. #### 4. Tie in scores

When athletes have equal scores, their results are considered tied, and it does not affect the ranking of subsequent athletes.

#### 5. Competition Results and Announcement

The list of athletes who won All-around trophy, Team Trials certificate, gold, silver, and bronze medal awards will be announced on the event website by the organizing committee. A series of publicity reports will also be carried out through professional media co-organizers and multimedia networks.
