(I) Introduction

Starting in 2026, the Golden State International Wushu Championships — the largest Wushu competition in the United States, successfully held for seventeen editions — will officially be upgraded to the World Wushu Open Championships (WWOC).

This transformation marks an important innovation in the global promotion of Wushu, signifying a new stage for the event in terms of scale, level, and international influence.

(II) Event Highlights

This grand event will bring together top athletes and delegations from around the world. Competition categories include traditional Kungfu, modern Wushu, Shaolin, Wing Chun, Taijiquan, and Health Qigong, featuring individual events, sparring, and group performances — showcasing the essence of various schools and styles of Chinese martial arts.

(III) Competition Information

- 1. Competition Dates: September 5–6, 2026
- Venue: Santa Clara Convention Center
 Address: 5001 Great America Parkway, Santa Clara, CA 95054
- 3. Official Hotel:
 - Delta Hotels Santa Clara Silicon Valley
 Address: 2151 Laurelwood Rd, Santa Clara, CA 95054.
 The hotel is approximately 1.1 miles from the Santa Clara Convention Center (about 4 minutes by car). It offers very convenient access, making it easy to reach the venue by driving.
 - 2) Hyatt Regency Santa Clara
 Address: 5101 Great America Pkwy, Santa Clara, CA 95054.
 The hotel is directly connected to the Santa Clara Convention Center.
- 4. Airport Information

- 1) San Francisco International Airport (SFO): 29.7 miles, approximately 31 minutes by car to the competition hotel.
- 2) San Jose International Airport (SJC): 5.7 miles, approximately 10 minutes by car to the competition hotel.
- 3) Transportation Options
 - Option 1 Public Transit: From SFO, take BART to Millbrae Station, then transfer to a southbound Caltrain directly to Santa Clara Station. The entire trip takes about 1 hour and 10 minutes, with a fare of \$9–\$12.
 - Option 2 Ride Share / Taxi: From SFO, you can take Uber, Lyft, or a taxi, costing \$45–\$100 and taking 35–50 minutes.
- 4) Pick-up Locations: The airport provides designated Rideshare Pickup areas.
 - Domestic Flights (Terminals 1, 2, 3): Outside the Arrivals level at designated "Rideshare Pickup" zones.
 - o International Flights (Terminals G, A): on garage level 5 of the parking structure.

IV Competitor Eligibility & Invitations

- 1. All participants must agree to the competition regulations, judging and arbitration procedures, and the waiver of liability before they are eligible to register.
- 2. World Wushu Open Championships: An international competition open to all with no restrictions.
- 3. All-Around Champion and Overall All-Around Grand Champion Finals Preliminaries: An international competition open to all with no restrictions.
- 4. All-Around Champion and Overall All-Around Grand Champion Finals: Only athletes selected in 2025 are eligible to participate.
- 5. Wushu Scholarship Preliminary Selection: An international event open to athletes aged 10–19 who register for the all-around competition.
- 6. Final Evaluation for Wushu Scholarships: Determined by the results of the Overall All-Around Grand Champion.
- 7. Selection of the Wushu Overall All-Around Grand Champion Team: All athletes who advance to the Grand Finals are eligible for selection.
- 8. U.S. National Kungfu Team Trials: Participants must be current members of the United States of America Wushu-Kungfu Federation (USAWKF) and must be U.S. citizens or permanent residents. Those who need to join USAWKF may register at www.usawkf.org
- 9. Invitations for International Teams or Individuals:
 - a. Participants must first complete registration by filling out the online application form on the official competition website or the attached registration form, then contact the Organizing Committee to request an invitation letter.
 - b. The Organizing Committee will issue an electronic invitation letter free of charge based on the submitted information.
 - c. If an original invitation letter is required, please contact the Organizing Committee with a valid mailing address and pay a \$50 international courier fee for delivery

V. Competition Grouping

1. Grouping Principles

1) Events are categorized based on the difficulty level of routines. The event list already includes beginner, intermediate, and advanced routines, such as Five-Step Routine, Basic Changquan, compulsory routines, and optional routines. Competitors only need to select their routine; they do not need to apply separately for "beginner, intermediate, or advanced level."

- 2) Separate traditional events are also set for different Wushu styles and weapon categories.
- 3) Grouping also considers the age distribution of participants and the number of competitors in each event.
- 2. Age Groups (On-site Competition, Age is calculated based on the birth date and the actual competition date, September 5, 2026.)
 - A. Group A: 6 years old and under
 - B. Group B: 7 years old
 - C. Group C: 8 years old
 - D. Group D: 9 years old
 - E. Group E: 10 years old
 - F. Group F: 11 years old
 - G. Group G: 12 years old
 - H. Group H: 13 years old
 - I. Group I: 14 years old
 - J. Group J: 15 years old
 - K. Group K: 16 years old
 - L. Group L: 17-19 years old
 - M. Group M: 20-25 years old
 - N. Group N: 26-35 years old
 - O. Group O: 36-55 years old
 - P. Group P: 56-69 years old
 - Q. Group Q: 70–89 years old
- 3. All-Around Events (by gender, age group, and category: Traditional Wushu, Modern Wushu, Taiji & Health Qigong)
 - 1) Traditional Wushu & Modern Wushu All-Around
 - o Same age categories for both Traditional and Modern groups:
 - a) All-Around Group A: Under 7 years old
 - b) All-Around Group B: 8–9 years old
 - c) All-Around Group C: 10 years old
 - d) All-Around Group D: 11 years old
 - e) All-Around Group E: 12 years old
 - f) All-Around Group F: 13 years old
 - g) All-Around Group G: 14 years old
 - h) All-Around Group H: 15 years old
 - i) All-Around Group I: 16 years old
 - i) All-Around Group J: 17–19 years old
 - k) All-Around Group K: 20–25 years old
 - 1) All-Around Group L: 26-55 years old
 - m) All-Around Group M: 56 years old and above

- Requirements for Competing in Both Modern and Traditional Wushu All-Around Events:
 - Modern Wushu All-Around: Competitors must register for at least one modern bare-hand routine, one modern short weapon, and one modern long weapon routine.
 - Traditional Wushu All-Around: Competitors must register for at least one traditional bare-hand routine, one traditional short or flexible weapon, and one traditional long weapon routine.
- 2) Taiji & Health Qigong All-Around
 - a) All-Around Group I: 11 years old and under
 - b) All-Around Group J: 12-16 years old
 - c) All-Around Group K: 17-19 years old
 - d) All-Around Group L: 20-25 years old
 - e) All-Around Group M: 26-55 years old
 - f) All-Around Group N: 56 years old and above
 - Requirements for Competing in Both Taijiquan and Health Qigong All-Around Events:
 - Athletes must register for at least one Taijiquan routine and one Health Qigong routine (bare-hand + apparatus).
 - Evaluation Method: All-Around events are not held as separate competitions. Instead, the sum of the highest scores from each athlete's respective categories will determine the All-Around ranking.
- 4. List of Competition Events and Codes

Please refer to the section "From 1 California International Wushu Championships Event Codes" at the end of this regulation.

5. Online Competition Events

There will be no All-Around Competition and no U.S. National Kungfu Team Selection in the online competition. The online events are the same as the on-site competition, but the age groups are different, divided as follows:

(Age is calculated based on the date of birth and the actual competition date, September 5, 2026.)

- (Group A): Age 6 and under
- (Group B): Ages 7–8
- (Group C): Ages 9–10
- (Group D): Ages 11–12
- (Group E): Ages 13–15
- (Group F): Ages 16–18
- (Group G): Ages 19–25
- (Group H): Ages 26–35
- (Group I): Ages 36–55
- (Group J): Ages 56–65

- (Group K): Age 66 and above
- 6. All-Around Competition Scoring and Tie-Breaking Rules
 - 1) For Modern Wushu and Traditional Wushu: All-Around Score = best Hand Form + best Short Weapon (Including soft weapons) + best Long Weapon. Highest total wins.
 - 2) For Taijiquan All-Around: All-Around Score = best Taijiquan + best Taiji Weapon. Highest total wins.
 - 3) If scores are tied, rankings will be determined in the following order:
 - Higher placement in any All-Around event ranks higher.
 - Higher single-event score ranks higher.
 - Better placements in other events rank higher.
 - Higher scores in other events rank higher.
 - If still tied, competitors remain tied.

VI. Overall All-Around Grand Champion & Scholarship Selection

- 1. 2026 Overall All-Around Grand Champion Finals & Scholarship Selection
 The 28 athletes who pass the 2025 preliminaries will compete in the 2026 finals.
 Scholarships totaling \$15,000 plus any additional funds raised will be distributed based on final results and ranking (the actual amount will be announced before the event).
- 2. 2026 Preliminaries & 2027 Finals + Scholarship Selection (Structure: preliminaries in 2026; finals and scholarship selection in 2027.)
- 3. Expanded 2026 Scholarship Preliminaries
 The 2026 preliminary quota increases to 60 athletes, and the initial scholarship pool doubles to \$30,000.
 - All award recipients may collect their full scholarship on site. Scholarship funds are at the athletes' discretion, but should be used for Wushu-related purposes such as tuition at training schools, uniforms, and equipment.

- 4. In the 2026 World Wushu Open Championships, 60 athletes will be selected from the Modern and Traditional All-Around events (ages 10–19) and the Taijiquan All-Around events (ages 12–19) to participate in the 2027 Finals and Scholarship Selection.
- 5. The Finals and Scholarship Selection will be conducted by event and by gender, but not by age group, with winners determined according to overall scores.
- 6. Scholarship Amounts:
 - 1) 12 First Prizes Awarded the "Golden Dragon" Wushu Scholarship and Plaque (\$1000 + additional fundraising)
 - 2) 18 Second Prizes Awarded the "Silver Tiger" Wushu Scholarship and Plaque (\$600 + additional fundraising)
 - 3) 24 Third Prizes Awarded the "Bronze Crane" Wushu Scholarship and Plaque (\$300 + additional fundraising)

7. Honors & Awards for the Overall Champion

Based on competition results, the Organizing Committee will establish an "Annual Overall All-around Grand Champion Ranking" on the official WWOC and WTSF websites, and form the WWOC World Wushu Champion Team.

- 8. Athletes selected into the Overall All-Around Grand Champion Team will receive:
 - 1) WWOC Overall All-Around Grand Champion Team uniform.
 - 2) The opportunity to be listed in the WWOC Grand Champions Hall of Fame. This honor is awarded to athletes who have won the Overall All-around Grand Champion title and the highest scholarship three times or more.
 - 3) Once inducted into the Hall of Fame, athletes will no longer participate in future Overall All-around Grand Champion or scholarship evaluations, allowing more opportunities for emerging young athletes.
- 9. Competition Rules for the Overall Champion Finals
 - 1) Event Selection

Athletes who qualify for the Overall All-around Grand Champion Final may freely choose one routine in the registration system that best represents their competitive



strength. The selected event must be in the same category as the one in which they qualified during the preliminary round, such as: Traditional Kungfu, Modern Wushu, or Taiji & Qigong. Each athlete may only select one event and will have only one competition opportunity.

- 2) Order of Appearance
 The order of appearance will be determined by electronic lot drawing.
- 3) Grouping Rules
 For the Overall All-around Grand Champion, athletes will be grouped only by
 "Category" and "Gender." No age groups will be applied.
- 4) Judges & Scoring Method
 - a. The Organizing Committee will draw 15 judges, using a 10-point scoring system
 - b. There will be no difficulty score requirement and no compulsory movements in this round.
 - c. Scoring calculation method:
 - a) The highest 6 scores and the lowest 6 scores will be removed.
 - b) The average of the middle 3 scores will be taken as the final score.
 - c) Rankings will be determined based on the final score, and scholarships will be awarded accordingly.
 - d. In case of a tie:
 - a) The athlete with the higher 2025 preliminary score will rank higher.
 - b) If still tied, the athlete with the higher single-event score in the all-around points will rank higher.

VII. Competition Time Requirements & Methods

- 1. Time and Participation Limits
 - 1) For athletes under 18, there is no time limit on the duration of routines.
 - 2) For athletes 18 and older, Traditional Kungfu routines must be at least 1 minute; compulsory routines and Modern Wushu routines must comply with their respective prescribed time requirements.
 - 3) Taijiquan and Health Qigong: individual and group events must not exceed 4 minutes; Kungfu group routines must not exceed 4 minutes; sparring/duilian events must last at least 40 seconds. If the time limit prevents completion of the routine, no deduction will be applied.
 - 4) For prescribed Wushu events, athletes must strictly follow the prescribed sequence without adding, removing, or changing movements.
 - 5) In sparring and group events, there are no gender or age restrictions. Each group event must have at least 6 participants; for each missing member, 0.5 points will be deducted.
 - 6) If fewer than 3 participants register for a given event in the same age group, it will be merged with a similar event.

- 7) Music accompaniment is not required, except for routines where regulations explicitly require it.
- 8) USAWKF U.S. Kungfu Team Selection Method (open only to USAWKF members):
 - a. Athletes scoring above 8 points or placing in the top 3 qualify.
 - b. Qualified athletes are eligible for 2 years to represent the U.S. Traditional Kungfu Team in world traditional kungfu championships, Pan-American traditional kungfu tournaments, and other international traditional Wushu competitions.
- 2. Online Competition Video Requirements
 - 1) At the start and end of the routine, athletes must face the camera and perform the bow-salute (bingbu baoqianli).
 - 2) Video recording must use a single camera at adult eye-level height, facing the athlete. The camera may pan left/right with the performance or zoom appropriately to keep the athlete clearly visible without appearing too small or out of frame. The entire routine must be filmed in one take with no cuts or edits. Multiple attempts are allowed, but only the best version may be submitted.
 - 3) Videos must be recorded in real time with no post-production editing or added audio/visual effects.
 - 4) Filming venue requirements:
 - a. Venue choice is not judged; athletes may freely select indoor or outdoor venues, provided they are safe and suitable for a complete routine performance and recording.
 - b. Lighting must be adequate for judges' evaluation.
 - c. Background must not display commercial advertisements, religious, or political propaganda. Martial arts school logos and national/regional flags are allowed.
 - d. Videos must be recorded within 2 months before the registration deadline. If any video is deemed non-compliant during the competition, the Organizing Committee reserves the right to disqualify it from scoring; registration fees will not be refunded.
- 3. Clothing and Equipment Requirements

Competition uniforms and equipment must comply with the 2024 IWUF competition rules. However, no specific requirements will be set for weapon length or weight.

4. Competition Drawing (Order of Appearance)

The order of appearance will be determined by an online drawing/lottery system.

- All teams and individuals must carefully review their submitted competition information before the draw.
- After confirmation, the team leader, coach, or athlete must complete the drawing through the online registration system.
- Drawing times will be announced on the competition website, registration system, and by email notifications.
- Athletes who fail to participate in the draw will have their order randomly assigned by the Organizing Committee.



VIII. Competition Format & Rules

1. Competition Format

- 1) The World Wushu Open Championships will include two formats: onsite competition and online competition. During the event, activities will include the All-Around Competition, Preliminaries and Finals of the Overall Champion, the Youth Wushu Elite Scholarship Selection, as well as the U.S. Traditional Kungfu Team Selection.
- 2) Competition events include individual, sparring (duilian), group, and all-around events. However, no team overall score competition will be set. In addition, the online competition will not include all-around events.

2. Competition Rules

- 1) Modern Wushu competitions will follow the 2024 IWUF Competition Rules, as approved by the International Wushu Federation, along with provisions in this regulation.
- 2) Traditional Kungfu competitions will follow the 2019 IWUF Traditional Wushu Routines Competition Rules, as well as this regulation.
- 3) Health Qigong competitions will follow the 2012 Health Qigong Competition Rules, together with relevant provisions in this regulation.
- 4) For Modern Wushu events, difficulty scores will not be applied.
- 5) For all competition rules, any provisions not applicable to online competitions will not be penalized in this event.

3. Arbitration Committee

- 1) Members of the Arbitration Committee will be appointed by the Organizing Committee.
- 2) Their responsibilities will follow the 2024 IWUF Routines Competition Rules, the Regulations on Arbitration Committees, and relevant provisions of this regulation.
- 3) The same procedures apply to Taijiquan, Health Qigong, and Wushu events. Online competitions will apply these procedures where relevant.

4. Arbitration Management

All evaluations, scoring, rankings, and awards (including the Overall All-Around Grand Champion and scholarship selections) shall be independently determined by the panel of judges appointed by the Organizing Committee in accordance with the established rules. Any dispute regarding judging results must be submitted strictly in accordance with the procedures set forth in the *Competition Appeals and Arbitration Regulations*. The final ruling made by the Arbitration Committee is conclusive and binding, and no further appeals, disputes, or requests for modification beyond the scope of arbitration will be accepted. Participants who do not agree with these provisions shall refrain from entering the competition; those who have already registered and do not accept these terms will be considered to have withdrawn voluntarily, and registration fees are non-refundable.

5. Competition Management

The competition will be conducted under the unified direction of the Organizing Committee. The Organizing Committee reserves the final right of interpretation for the competition regulations and rules. In the event of any discrepancy or dispute regarding the interpretation of the English version of the regulations or rules, the Chinese version shall prevail.



IX. Judges Selection & Scoring Methods

1. Judges Selection

The panel will consist of members of the Arbitration Committee, Chief Judge, Head Judges, and Scoring Judges, appointed from experienced international, Pan-American, and national-level referees.

2. Scoring Method

- 1) Five judges: the highest and lowest scores are discarded; the average of the middle three scores is the final score.
- 2) Four judges: the highest and lowest scores are discarded; the average of the middle two scores is the final score.
- 3) Three judges: the average of all three scores is the final score.

3. Scheduling Conflicts

If event times are too close or conflict, athletes may apply in advance to the Head Judges of both arenas. Depending on the situation, their performance may be rescheduled earlier or later to avoid conflicts. Head Judges may adjust the competition order accordingly. However, if the athlete cannot compete before all competitors in their group have finished, the event will be considered a forfeit.

4. Multiple Athletes Competing Simultaneously

The judging panel may allow multiple athletes to compete simultaneously if the style and characteristics of the event permit, provided judging quality and venue safety are maintained.

5. Head Judge Adjustments

If a score is deemed clearly unreasonable, the Head Judge may adjust it by ± 0.01 –0.05 before the final score is announced, without requiring approval from the Chief Judge.

X. Rankings & Awards

1. First-Time Participation Encouragement Award

Athletes participating for the first time must indicate this during online registration. First-time participants and those who complete all their events without winning a medal will receive an Encouragement Medal.

2. Onsite Competition

- 1) The top three athletes in each individual event will be awarded gold, silver, and bronze medals, along with electronic certificates. Other athletes will receive electronic certificates.
- 2) In sparring (duilian) and group events, awards follow the same method. Medals will be awarded based on the actual number of participants in each group.
- 3) In all-around events, athletes' two or three highest scores from their individual events (per all-around registration requirements) will determine the overall ranking. The top

three athletes will receive all-around championship titles, trophies, medals, and certificates.

- 4) Certificates can be downloaded directly from the athlete's competition registration account. If registered by a coach or school, athletes should contact them to obtain certificates.
- 5) Medals and trophies for onsite competitions can be collected at the Awards Center during the event.
- 6) Results for all-around events will only be announced after all events in that age group are completed. All-around trophies can be collected onsite.
- 7) Results for the Kungfu Team Selection will be announced onsite. However, selection certificates must be verified and confirmed by USAWKF (approximately two weeks), after which they will be available for download from the registration account.

3. Online Competition

- 1) Online competitions will award tiered medals:
 - o Gold (1st Prize) \rightarrow 20% of participants
 - o Silver (2nd Prize) \rightarrow 30% of participants
 - o Bronze (3rd Prize) \rightarrow 30% of participants
 - o Remaining participants → Encouragement Award (Participation Certificate)
 - Percentages are based on the actual number of participants, rounded using standard rules.
- 2) Certificates can be downloaded from the competition account. Medals for online competitions can be collected at the Organizing Committee's office or ordered via the sponsor KungFuDirect.com (under the "medals" section). Shipping and customs fees are the responsibility of the recipient.

4. Ties

Except in all-around events, tied scores will result in tied rankings without affecting subsequent rankings.

5. Results Publication

The list of athletes receiving all-around trophies, selection certificates, and medal awards (gold, silver, bronze) will be officially published by the Organizing Committee on the competition's official website.

XI. Registration Methods & Requirements

1. Insurance & Waiver of Liability

- 1) All participants must obtain their own insurance, including: medical insurance, personal injury insurance, liability insurance, travel insurance, illness insurance, and other related coverage.
- 2) Whether registering online or by mail, participants must either confirm their agreement to the waiver in the online registration system, or submit a signed waiver

form to the Organizing Committee at onsite check-in, in order to qualify for participation.

2. Athlete Registration

- 1) Athletes may register for both onsite competitions and online competitions, with no limit to the number or type of events.
- 2) There is no limit to the number of athletes per team; however, each athlete may only represent one team throughout the competition.

3. Team Registration

1) Team Leaders & Coaches

- a. Teams with more than five athletes are eligible to apply for group registration.
- b. Each team may register 1 team leader and up to 2 coaches.
- c. Registration is conducted through the official competition registration system, where credentials will be issued.
- d. Accredited leaders and coaches may enter the competition venue free of charge and exercise their respective duties.

2) Accompanying Referees

- Teams with more than 20 athletes may register 1 qualified Wushu referee as an accompanying referee.
- This referee must be approved by the Organizing Committee to serve as an official competition judge (Please complete registration through the unified registration system).

XII. Opening Ceremony Entry Procedures

- 1. All participating teams and individual athletes are encouraged to attend the Opening Ceremony on time.
- 2. It is recommended that teams enter the ceremony in uniform (team jacket or competition attire).
- 3. Teams with more than five athletes will be provided with a team entry placard and team flag by the Organizing Committee. Teams with fewer than five athletes will enter together with individual participants, using the unified individual entry placard and flag.
- 4. Placard bearers and flag bearers: Each team must designate one placard bearer and one flag bearer. The entry order shall be: placard bearer → flag bearer → team leader → coaches → athletes and accompanying members.
- 5. Each team must submit its team name and the flag bearer's contact information to the Organizing Committee before the registration deadline, in order to receive the entry route, lineup arrangement, and participate in the rehearsal.
- 6. This year's entry order will follow the reverse alphabetical order of team names in English, from Z to A. The detailed route map and rehearsal schedule will be announced separately.



7. After the Opening Ceremony concludes, the flag bearer and placard bearer are responsible for guiding their team to exit the venue in an orderly manner.

XIII. Registration Process & Fees

2. Onsite Competition Fees

- 1) Individual Events: \$85 registration fee (not including the first event); \$35 per additional event.
- 2) Sparring (Duilian) Events: In addition to the registration fee, each athlete pays \$35 per event.
- 3) All-Around Competition fee: \$80.
- 4) National Kung Fu Team Trials registration fee: \$50 per event.
- 5) Group Events: No registration fee; \$35 per athlete, per event.

3. Online Competition Fees

- 1) Registration fee: \$40 (not including the first event).
- 2) Additional events: \$20 per event.

5. Event Changes & Refunds

- 1) Before the registration deadline, athletes may contact the Organizing Committee via email, phone, or WeChat to modify their registration information or withdraw, with full refund available.
- 2) After the registration deadline, cancellations will be considered a forfeit, and no refund will be issued.
- 3) After the registration deadline but before the drawing of lots, athletes who wish to change or cancel their registration must pay a \$50 administrative fee.

6. Ticket (Wristband) Prices

- 1) Two-day pass: \$50; One-day ticket: \$30
- 2) Free admission for:
 - a. All registered athletes with athlete passes and wristbands
 - b. Team leaders, coaches, referees, and volunteers with official credentials and wristbands (must register before the deadline to collect credentials)
 - c. Children under 6 years old
- 3) All ticket wristbands are non-refundable once sold.

- 1) All competition fees must be paid through the online registration system.

- 3) A 3.9% processing fee applies to all credit card transactions.

Before participating in the World Wushu Open Championships (WWOC), authorized and recognized by the World Taiji Science Federation (WTSF) and the USA Wushu-Kungfu Federation (USAWKF), as well as any related training, demonstrations, and activities, I hereby confirm that I have fully read this agreement and voluntarily agree to the following terms:

I understand that martial arts, Taiji, Qigong, and related athletic activities involve inherent risks, including but not limited to sprains, strains, fractures, collisions, falls, accidental contact, risks associated with equipment or venue conditions, and exposure to infectious diseases (such as influenza or COVID-19). I voluntarily assume all known and unknown risks associated with participation.

To the fullest extent permitted by law, I agree to release and waive any liability claims against the World Wushu Open Championships (WWOC), the World Taiji Science Federation (WTSF), the USA Wushu-Kungfu Federation (USAWKF), the Organizing Committee, judges, staff, volunteers, hosting and partnering organizations, and the owners and managers of the venue, including any injuries, illnesses, accidents, property loss, or life-threatening incidents that may occur as a result of my participation.
