WAIVER AND RELEASE

I understand that participation in martial arts activities, including but not limited to Wushu, Kung Fu, Taijiquan, Sanda, weapons events, demonstrations, workshops, training sessions, and competitions, involves inherent risks of injury, illness, property loss, permanent disability, and even death.

In consideration of being permitted to participate in the 2026 World Wushu Open Championships ("Event"), I voluntarily agree to the following:

1. ASSUMPTION OF RISK

I acknowledge that participation in the Event is entirely voluntary and that I knowingly and freely assume all risks, both known and unknown, arising from my participation, including but not limited to:

- Physical injury or illness
- Falls, collisions, or contact with participants or equipment
- Equipment malfunction or failure
- Negligence of other participants, spectators, or event personnel
- Travel to and from the Event
- Emergency situations beyond the control of the organizers

I accept full responsibility for any injury, loss, damage, or expense that may occur as a result of my participation.

2. HEALTH CERTIFICATION

I certify that I am physically fit, medically able, and adequately trained to participate in the Event. I understand that it is my responsibility to consult a physician if I have any concerns regarding my physical condition. I further certify that I have no medical condition that would prevent my safe participation in the Event.

3. RELEASE OF LIABILITY

To the fullest extent permitted by law, I hereby release, waive, discharge, and covenant not to sue:

- World Taiji Science Federation (WTSF)
- USA Wushu Kungfu Federation (USAWKF)
- World Wushu Open Championships Organizing Committee
- Santa Clara Convention Center
- Event sponsors and partners
- Judges, coaches, officials, volunteers, staff, and agents
- Any affiliated organizations or individuals associated with the Event

from any and all claims, liabilities, demands, actions, causes of action, damages, losses, costs, or expenses arising out of or related to my participation in the Event, whether caused by negligence or otherwise.

4. MEDICAL AUTHORIZATION

In the event of an injury, illness, or medical emergency, I authorize the Event organizers, staff, and emergency personnel to obtain medical treatment on my behalf if necessary. I understand and agree that I am solely responsible for all medical expenses and related costs incurred as a result of such treatment.

5. PROPERTY DAMAGE

I accept full responsibility for any personal property brought to the Event. The Event organizers shall not be responsible for any loss, theft, or damage to personal belongings.

6. MEDIA RELEASE

I grant permission to WTSF, USAWKF, and the Event organizers to photograph, videotape, record, broadcast, publish, and otherwise use my image, likeness, voice, name, and performance for promotional, educational, archival, media, social media, livestream, publication, and marketing purposes without compensation or further approval. All such materials shall remain the property of the Event organizers.

7. MINOR PARTICIPANTS

Participants under eighteen (18) years of age must have this waiver signed by a parent or legal guardian. The parent or legal guardian acknowledges and agrees to all terms of this waiver on behalf of the minor participant.

8. GOVERNING LAW

This Agreement shall be governed by and interpreted under the laws of the State of California, USA. Any dispute arising from this Agreement shall be resolved exclusively in the courts located in California.
