



THE 1ST WORLD WUSHU OPEN CHAMPIONSHIPS (WWOC)

ONLINE VIDEO COMPETITION REGULATIONS

Welcome Wushu enthusiasts from around the world to participate in this prestigious international Wushu event by recording and submitting competition videos online.

The Online Video Competition provides participants with a convenient platform to showcase their skills to the global Wushu community. It also offers an excellent opportunity to become familiar with competition procedures and rules while preparing for future participation in the Overall Grand Champion Finals and the International Youth Wushu Scholarship Program.

I. EVENT TITLE

2026 The 1st World Wushu Open Championships (WWOC) Online Video Competition

Host Organization: World Taiji Science Federation (WTSF)

Sanctioned By: United States of America Wushu Kungfu Federation (USAWKF)

II. COMPETITION FORMAT AND ELIGIBILITY

1. Athletes shall submit competition videos through the official event website. Videos will be evaluated by internationally or nationally certified judges.
2. The Online Video Competition is conducted through video submission and is not restricted by geographical location.
3. The WWOC Online Video Competition is a world-class event open to athletes and teams worldwide. Any individual or organization that agrees to comply with these regulations and related competition rules may participate.

III. COMPETITION SCHEDULE

1. Registration Period: May 1, 2026 – September 1, 2026
2. Video Submission Deadline: September 1, 2026, 11:59 PM (Pacific Time, USA)



3. Judges' Evaluation Period: September 12 – September 19, 2026
4. Results Announcement: On or before September 20, 2026

IV. COMPETITION DIVISIONS

1. Division Principles

(1) Competition events are categorized according to the degree of difficulty of the routines. Event categories already include beginner, intermediate, and advanced routines, such as Five-Step Fist, Basic Changquan, Compulsory Routines, and Optional Routines. Athletes are only required to select the routine they wish to perform and are not required to separately declare their skill level.

(2) Traditional events are provided for different styles of Wushu and weapon categories.

(3) Competition divisions take into consideration participants' age distribution and the number of entries in each event.

2. Age Divisions

The Online Video Competition includes Duilian (Sparring Sets) and Group Events but does not include Overall Championship Events.

Age is determined according to the athlete's date of birth and the official competition date (September 1, 2026).

Group A: 6 years old and under

Group B: 7–8 years old

Group C: 9–10 years old

Group D: 11–12 years old

Group E: 13–15 years old

Group F: 16–18 years old

Group H: 26–35 years old

Group I: 36–55 years old



Group J: 56–65 years old

Group K: 66 years old and above

V. ENTRY REQUIREMENTS

1. Insurance and Waiver Requirements

(1) All participants must obtain their own insurance coverage, including but not limited to medical insurance, personal injury insurance, liability insurance, illness insurance, and any other applicable insurance.

(2) Participants must acknowledge and accept the official liability waiver through the online registration system before being eligible to compete.

2. Athlete Registration

Athletes may register for both the onsite competition and the Online Video Competition.

There is no limit on the number of online competition events entered or the number of athletes represented by a team. However, each athlete may represent only one team during the competition.

3. Team Registration

(1) Both individual athletes and teams may participate. Team participants may select their affiliated school or organization when completing athlete registration information.

(2) If a school or organization is not listed in the registration system, participants may create a new team entry according to the system instructions.

VI. TIME REQUIREMENTS AND COMPETITION PROCEDURES



1. Time and Participation Requirements

- (1) There is no time limit for routines performed in the Online Video Competition.
- (2) Compulsory Wushu events must be performed in the prescribed sequence. No additions, omissions, or modifications to movements are permitted.
- (3) Duilian and Group Events have no gender or age restrictions.

Each group event must include a minimum of six (6) participants. A deduction of 0.1 points will be applied for each participant fewer than six, with an absolute minimum of four participants.

Except for certain original choreography events, participants may choose whether or not to use music accompaniment.

- (4) If fewer than three competitors are entered in the same event and age division, the Organizing Committee reserves the right to combine the event with a similar category for judging purposes.

2. Video Submission Requirements

- (1) At the beginning and end of the performance, athletes must face the camera and perform the traditional Baoquan Salute with feet together.
- (2) Competition videos must be recorded using a single camera positioned at approximately adult eye level and facing the athlete directly.

The camera may move laterally during the performance and zoom may be adjusted appropriately to ensure the athlete remains fully visible.

The entire performance must be recorded continuously in a single take. Editing, cuts, or scene changes are not permitted.

Multiple recordings are allowed, and athletes may submit their best performance.



(3) Competition videos must be recorded in real time. Post-production editing, audio enhancements, and visual effects are strictly prohibited.

(4) Venue Requirements

a. The filming location will not be considered as a scoring factor. Participants may choose either an indoor or outdoor location, provided it is safe, suitable for complete performance execution, and appropriate for video recording.

b. Lighting and visibility must be sufficient to allow judges to evaluate the performance accurately.

c. Commercial advertising, religious promotion, and political propaganda are not permitted in the video background. School logos and internationally recognized national or regional flags are permitted.

d. Videos must comply with all competition requirements. The recording date must be within six (6) months prior to the registration deadline. Videos that fail to meet the requirements may be disqualified from judging, and registration fees will not be refunded.

3. Uniform and Equipment Requirements

Competition uniforms and equipment shall comply with the requirements of the 2024 International Wushu Federation (IWUF) Competition Rules. No specific requirements are imposed regarding weapon length or weight.

VII. COMPETITION RULES

1. Competition Rules

Modern Wushu events shall be conducted in accordance with the 2024 IWUF Taolu Competition Rules and these Regulations.



Traditional Wushu events shall be conducted in accordance with the 2019 IWUF Traditional Wushu Competition Rules and these Regulations.

Health Qigong events shall be conducted in accordance with the Health Qigong Competition Rules (2012) and these Regulations.

All Modern Wushu events will utilize the Non-Difficulty Scoring Method.

Any provisions of the competition rules that are not applicable to online judging shall not be implemented for this competition.

2. Arbitration Committee

Members of the Arbitration Committee shall be appointed by the Organizing Committee.

The Committee shall perform its duties in accordance with the Arbitration Committee Regulations contained within the 2024 IWUF Taolu Competition Rules and these Regulations.

The same arbitration procedures shall apply to Taijiquan, Health Qigong, and Wushu events, with adjustments made as necessary for the online competition format.

3. Competition Administration

The competition shall be conducted under the unified leadership of the Organizing Committee.

The Organizing Committee reserves the right of final interpretation of these Competition Regulations and Competition Rules.

In the event of any discrepancy between the Chinese and English versions, the Chinese version shall prevail.

VIII. RANKINGS AND AWARDS



1. Award Categories

The Online Video Competition shall use a Grading Award System.

Awards will be presented separately by event, age division, and gender:

First Prize (Gold Award): Top 20%

Second Prize (Silver Award): Top 30%

Third Prize (Bronze Award): Top 30%

Participation Award: Remaining participants (Certificate of Participation)

Award percentages shall be calculated based on the actual number of participants and rounded to the nearest whole number.

2. Electronic Certificates

Electronic certificates may be downloaded directly through the participant's registration account.

Participants who wish to receive physical medals similar to those awarded at the onsite competition may apply for medal shipping through the designated link or QR code.

Medals are provided free of charge; however, shipping costs, customs duties, and any related fees shall be the responsibility of the recipient.

3. Medal Shipping for Asian Participants

Participants located in Asia may contact the Organizing Committee via WeChat or email to request medal shipment.

After results are verified, medals will be shipped from Guangzhou on a collect-upon-delivery basis.

For team entries, medal shipment arrangements should be handled collectively.



4. Ties and Results Publication

Athletes receiving identical scores shall share the same ranking. Such ties shall not affect the rankings of other athletes.

Major award results will be published through the official event website and registration system.

IX. REGISTRATION PROCEDURES AND FEES

1. Registration Process

2. Online Competition Fees

Online Competition Registration Fee: USD \$40 (excluding the first event fee)

Competition Event Fee: USD \$20 per event

Competition videos may be uploaded directly through the athlete's registration account.

Accepted video formats: MOV or MP4; Maximum file size per video: 500 MB.

3. Event Changes and Refund Policy

(1) Prior to the registration deadline, athletes may request changes to registration information by contacting the Organizing Committee via:

(2) After draw schedules have been finalized, no competition information may be changed.

After the registration deadline, withdrawals for personal reasons shall be regarded as forfeiture, and registration fees will not be refunded.



X. PAYMENT METHODS
